

**THE FOREST SHOP AND EARN  
TERMS AND CONDITIONS**

1. Applicable Activity

By participating in the activity (the "Activity") organized by New World Investments Limited ("NWIL") as set out in clause 2 below, a participant is deemed to have read, understood and agreed to the terms and conditions applicable to the Activity ("Terms and Conditions").

2. The Details of The Activity

- a) Each Eligible Receipt must contain a minimum net spending of HK\$50, excluding spending by K Dollar(s) and/or THE FOREST physical / electronic gift voucher(s) and/or any physical/electronic gift voucher(s) issued by merchants at THE FOREST;
- b) An original machine-printed receipt issued by the Merchants at THE FOREST on the date of redemption for an Eligible Transaction; and
- c) A corresponding electronic payment slip (if applicable) bearing the name of the Member.

NWIL does not accept any photocopies or hand-written receipts or payment slip and reserves the right not to accept any receipts or payment slip that NWIL suspects to be invalid, forged or issued not for genuine transactions or on other grounds without any need for explanation. An Eligible Receipt must be intact and complete for redemption, and will be invalid if found defaced or altered.

5. "Eligible Transaction" shall mean a consumer transaction between the consumer and a Merchant at THE FOREST using Electronic Payment, excluding the below transactions:

  - h) Adding value to Octopus cards, stored value cards or pre-paid cards;
  - i) Currency exchange;
  - j) Any online transaction with the merchants;
  - k) Any bank transaction;
  - l) Charity donations;
  - m) Any bill payment (including but not limited to payment of telecommunication or utility bills);
  - n) Any transactions on K11 ESHOP, K11 GO HK, Food Ordering via 'K11 HK' Mobile App or any online platform of any merchants; and
  - o) Any other transaction as specified by KLUB 11 from time to time (with or without prior notice).
